NFDA Fastener Standards Activity Update - Q2 2016

ASTM F16, ASME B18, and the associated subcommittees met in San Antonio, Texas May 2-4. Some of the major activities are as follows:

ASTM F16

- · Long-time member of F16, Quentin Smith, was recognized by ASTM with the Award of Merit.
- ASTM F1470 on sampling for mechanical and performance inspection will be reviewed by a task group for revision, as it has not seen one since 2012.
- Work continues towards the creation of a draft standard for quality assurance documentation, with the goal of providing a guide to standardize the way fastener quality and inspection reports are presented.
- During the meeting of F16.96 on Bolting Technology, I presented results of my Master's thesis research on hydrogen embrittlement susceptibility of case hardened fasteners. Based on the data generated so far, and proposed future studies, the subcommittee pledged \$15,000 from the research fund to support future work.
- Based on the data already gathered, the current 4 hour minimum bake time for case hardened fasteners in ASTM F1941/F1941M will be reviewed for removal.
- The major revision to ASTM A354 is nearing completion, with two negatives resolved at the May meetings. The draft will be balloted again, with approval expected later this year.
- The conflict in baking requirements between ASTM F1941/F1941M and ASTM B633 continues to cause issues in industry, with the American Petroleum Institute (API) issuing a formal request to ASTM to resolve. A meeting was held with members of F16 on Fasteners, A01 on Steel, and B08 on Coatings to share data in support of aligning B633 with F1941/F1941M. The next step is submitting the proposed change as a

John Medcalf was appointed as the NFDA technical standards representative to allow the NFDA membership not just visibility of standards activities, but also a voice in the process.

NFDA members are encouraged to express their comments or concerns relating to fastener standards. The only way to influence the process is to stay engaged and participate.

- Raise suggested revisions or technical updates to standards
- Ask general standards related questions
- Offer feedback to continue refinement of these articles

ballot within B08.

- The committee voted to disband Subcommittee 7 on Tubular and Split Rivets and transfer all related standards to SC1, formerly just Solid Rivets.
- The first major revision in many years to ASME B18.6.1 on Wood Screws is nearing ballot, with added head and drive styles, the addition of drywall screws, and updates to thread and body terminology.
- ASME B18.3 on Socket Screws will be reviewed for revision.
- ASME B18.18 on Quality Assurance will be balloted shortly, with the major change being clarifications to Category 3 requirements.

ISO TC2

Ad-hoc groups are meeting in Montreal in July, with the main items of business being revisions to ISO 4042 on electroplating, ISO
15330 on hydrogen embrittlement testing, ISO 3269 on acceptance inspection, ISO 898-2 on mechanical properties of nuts, and the
publishing of ISO technical report – Fundamentals of Hydrogen Embrittlement in Steel Fasteners.
